## **Course Description**

### **Course Curriculum**

This course introduces students to rhetorical concepts and audience-centered approaches to writing including composing processes, language conventions and style, and critical analysis and engagement with written texts and other forms of communication.

- Students will apply rhetorical knowledge to communicate for a range of audiences and purposes.
- Students will employ critical thinking to analyze forms of communication.
- Students will engage in writing processes that involve drafting, revising, and reflecting

# **Goals and Objectives**

- 1. Students will learn how to analyze an argument and break down the types of appeals being made as well as how effective those appeals are for the intended audience.
  - Students will be able to identify ethos, logos, and pathos
  - Analyze how these appeals and Kairos are used by other rhetors to make arguments and measure the success of those uses
  - Identify the intended audience and the appeals that are most effective for that group
- 2. Students will be able to complete research using various sources such as databases and newspapers

- Utilize available resources to effectively build evidence
- Be able to effectively navigate the databases
- Identify the difference between scholarly and popular sources
- 3. Students will be able to go through multiple stages of drafting and revising.
  - Develop a thesis and outline
  - Complete multiple drafts based on peer and instructor feedback
  - o Complete brainstorming exercise to develop ideas and arguments
- 4. Students will be able to reformat an argument for a new audience and medium
  - Analyze different audience needs and desires
  - o Analyze the limitations and affordances of various mediums
  - o Repurpose an academic argument paper for a public audience via a spoken medium

# **Student Expectations of the Course**

- Participation is required in this course
- Students will often work in small groups to gain hands on practice of the material
- Students will be expected to read and evaluate various arguments based on the intended audience and various appeals
- Students will be expected to complete a TedTalk for their final exam
- Students will have three points in the semester where they will be expected to make an appointment with the instructor to go over their drafts to get individualized feedback
- The instructor is available outside of class to discuss assignments or provide clarification of any lecture material.

### Class Attendance

Students who stop attending class or are not able to pass the course due to attendance expectations stated in the syllabus may receive a failing grade, which may impact the receipt of federal aid in subsequent courses. A. This class involves frequent class discussions/lab work/group work; students will neither benefit from these activities nor contribute to the class as a whole if students are frequently absent. #### **Attendance Confirmation**
