Course Curriculum

In Accordance with Florida State Legislation:

This course uses project-based learning to provide students rhetorical concepts and audience-centered approaches to writing, and includes composing processes, language conventions and style, and critical analysis and engagement with written texts and other forms of communication.

In this course, students will be provided instruction and intensive practice in expository and argumentative writing including a documented paper.

This is a Gordon Rule writing course ad is part of the college's Writing-Across-the-Curriculum program. A minimum grade of "C" is required if used to meet Gordon Rule requirements for general education.

Goals and Objectives

Students will learn how to develop and complete an argumentative essay. Students will develop scholarly practices involving research and synthesis. Students will learn how to apply knowledge gained in class in real-world application.

Student Expectations of the Course

Students will work both individually and collaboratively on writing assignments and projects.

How Student Performance Will be Measured

Student performance will be measured by essays, in-class assignments, and a multiple-choice final exam.

Course Description

Examines government, political ideals, and institutions. Strong emphasis is placed on political thought, the origin of the American federal system, and the distribution of powers between state and national governments. This is a Gordon Rule writing course and is part of the college's Writing-Across-the-Curriculum program. A minimum grade of "C" is required if used to meet Gordon Rule requirements for general education.

Course-Level Student Learning Outcomes

The student will:

- Demonstrate an understanding of the basic principles and practices of American democracy and how they are applied in our republican form of government (local, state, and federal).
- Assess the changing nature of political parties, party platforms, voting patterns among the American populace, and different methods to measure public opinion.
- Evaluate the three branches of the United States federal government to demonstrate an understanding of the duties of each specific branch and the application of checks and balances.
- Understand the interdependence of each institution of government and why the relationship developed.
- Explain the procedures and techniques used by various officials in the performance of their duties.
- Describe the process of policy making (foreign and domestic).
- Develop and demonstrate an understanding of the United States Constitution and amendments and their application.
- Develop and demonstrate knowledge of the founding documents and how they have shaped the nature and functions of our institutions of self-governance.
- Develop and demonstrate an understanding of landmark Supreme Court cases, landmark legislation, and landmark executive actions and their impact on law and society.

Course Materials

Our course text is an OER text American Government: Readings and Cases, Avarus Books provided free of charge for students and can be downloaded from within the course.

Class Attendance

Students who stop attending class or are not able to pass the course due to attendance expectations stated in the syllabus may receive a failing grade, which may impact the receipt of federal aid in subsequent courses. Students traveling for College-approved activities will not be penalized academically but will be responsible for missed work.

Attendance Confirmation

Start Here/Orientation (15 points)

After you have carefully proceeded through the first three steps of the Start Here items, do the Orientation Quiz (five points) and the Introductory Discussion (10 points).

Module Work

There are 14 Modules. Work through each module doing the readings, watching the videos, and doing the assignments in the order they appear on Canvas.

Chapter Quizzes (140 points)

There are 14 chapter quizzes in this course; they are not cumulative. Each quiz will have 10 questions. The format for each quiz is "open book" and each quiz has a time limit of 30 minutes. Make sure you study!!!

Each student will have two attempts per quiz. The higher grade will be recorded. If you do not finish an attempt, it may count as a zero. The quiz questions are pulled from a larger group of questions; therefore, no two attempts will have the exact same questions. By design, there is not enough time to look up each and every question, so study prior to taking the quiz. The quizzes are automated; they are generated from dozens of questions. The grade will post immediately after submission.

If you are taking a quiz on a wireless connection, make sure it is stable one. It is also suggested that you keep an Internet radio station active without volume during the quiz to ensure your connection stays active during the examination. On rare occasions, there may be an issue with the quiz questions. Please let me know if that is the case. I always appreciate help in catching errors in the quizzes. Always feel free to check the answers against the book – if you have a question about an answer marked wrong, just email me with the question and your evidence (a pic) from the online text or book.

Unforeseen glitches during a quiz attempt can occur from time to time. There are several steps you can take to ensure you do not have a problem during an attempt. Go ahead and contact me if you have any problems with the quiz, if it is a tech support problem, I'll refer you to them.

Written Assignments (500 points)

There are 14 written assignments that are worth varying amounts of points. Make sure you carefully read the instructions for the assignment and do all the requirements before turning in the assignment in Canvas.

Discussions Forums (220 points)

Each module discussion forum is worth 15 points (the concluding discussion is worth 10). To get the full points, you must write a 250-300-word response to the given prompt (use your software to count the number of words and include that at the end of your post). Your response should carefully address all parts of the question in a coherent, organized, and professional manner. You must also respond to someone else's post with a 100-word response (use word court again).

Your responses should be your own words. Do not cut and paste - this is plagiarism. If you do quote the textbook or other sources, be sure to use quotation marks and parenthetical citations for proper attribution. If you cut and paste and do not use your own words without quotations marks and parenthetical citations, you may be cited for plagiarism, given a 0 on the assignment, and an F in the course. You may also face possible disciplinary action by the College.

You will primarily be graded on the completeness of your posts. Make sure you read the comments made on your posts. If I ask a follow up question, make sure you answer to receive more points for your post.

The Final Exam covers all material in Chapters 1-14.

Incomplete Grades
